I have received numerous representations from residents of McBurney Avenue Mascot about the dangerous nature of the intersection of McBurney Avenue and Wentworth Avenue. Residents have witnessed many accidents at this intersection, and it is making it almost impossible for residents of McBurney Avenue to exit their street onto Wentworth Avenue during peak hour.

Residents have indicated to me that the main factor creating the trouble at this intersection is the fact cars can still turn right from Wentworth Avenue into Alfred Street when travelling westbound.

This is seeing cars stop on Wentworth Avenue and bank up until they can turn right. When this occurs, it is impossible for McBurney Avenue residents to turn right on to Wentworth Avenue.

The residents I have spoken to believe a solution to this problem would be to prohibit westbound traffic travelling on Wentworth Avenue from doing a right-hand turn onto Alfred Street. They feel that this would prevent a large number of vehicles from banking up on Wentworth Avenue allowing residents of McBurney Avenue to exit their street.

I respectfully request that your office investigate the feasibility of this suggestion as well as any other way to alleviate this dangerous traffic situation. I have also written to Ms Meredith Wallace, General Manager of Bayside Council to request that council also investigate a solution to this issue.
